[Pennsylvania Coal Bosses See Demand Up for Anthracite](#) - Lawmakers and coal executives huddled in a Pennsylvania high school gymnasium Oct. 4 to chart a future for a local specialty: anthracite coal.

[Electricity markets: States reassert authority over power generation](#) - States want the benefits of electricity markets but also want to dictate their outcomes. How federal regulators strike a balance will influence the power mix for decades to come.

[PJM Statement on Independent Review of GreenHat Energy Default](#) - The PJM Interconnection Board of Managers has commenced an independent review of the June 2018 default of GreenHat Energy LLC, a financial transmission rights (FTR) trader in the PJM markets.

[As DOE's Coal Rescue Reportedly Dead-Ends, Stakeholders Recommend New Pathways](#) - The White House may have shelved an effort to force grid operators to buy power from uneconomic coal and nuclear plants amid opposition inside the administration, Politico reported on October 15.

[Electricity generation reaches highest level since the 2008 recession](#) - America's electricity generation reached the highest level since before the economic recession, just-released government data shows.

[Carbon dioxide emissions from the U.S. power sector have declined 28% since 2005](#) - U.S. electric power sector carbon dioxide emissions (CO<sub>2</sub>) have declined 28% since 2005 because of slower electricity demand growth and changes in the mix of fuels used to generate electricity.

[US on pace for record coal retirements in 2018, IEEFA finds](#) - U.S. power providers will close more coal-fired generation capacity in 2018 than any year before, according to research released last week by the Institute for Energy Economics and Financial Analysis (IEEFA), a clean energy think tank.

[New campaign will ask coal users to face the 'cold hard economic case' against them](#) - Bruce Nilles, who led the charge against coal that shuttered 275 of the 530 U.S. coal plants as director of the Sierra Club Beyond Coal Campaign from 2002 to 2018, will now lead a new effort against the resource.

[Greens challenge Trump's rollback of coal ash standards](#) - Environmental groups are suing the Trump administration for rolling back parts of a major regulation governing how companies store coal ash.

[Competitive Generators Look to the Supreme Court After Seventh Circuit Declines Rehearing on Nuclear Subsidies](#) - The Seventh Circuit Court of Appeals has declined to rehear a case that challenges nuclear subsidies in Illinois, effectively dealing a blow to a group of competitive generators, which have fought the measure for several years.

[Study: Natural gas, wind, solar cheapest power generation](#) - Natural gas, solar and wind are the cheapest ways to generate electric power, according to a new study released by the University of Texas at Austin's Energy Institute on Thursday.

[More than 16 GW of coal-fired capacity to retire by 2021, FERC staff](#) - More than 37 GW of generation capacity has been proposed to retire by September 2021, including 16.3 GW of coal-fired capacity, 12 GW of gas-fired power and 8 GW of nuclear generation, according to the US Federal Energy Regulatory Commission staff's monthly infrastructure report.

[Agency: Regional electric power grid relying more on natural gas-fired plants](#) - The nation's largest regional power grid is relying increasingly on natural gas-fired power plants for its electrical power supply, the U.S. Energy Information Administration said Wednesday.

[Exelon makes last push to save Pa. nuclear plant as federal action stalls](#) - With the clock ticking on Exelon Corp.'s Three Mile Island power plant, nuclear energy proponents hope Pennsylvania lawmakers will propose legislation in early 2019 to bolster the state's nuclear fleet as that industry sector grapples with competitive natural gas-fired generation and slack demand growth.

[Court Upholds Water Intake Rule, Offering Some Certainty for Power Plants](#) - The U.S. Court of Appeals for the Second Circuit in July issued a long-awaited decision in the case Cooling Water Intake Structure Coalition v. U.S. Environmental Protection Agency (EPA), upholding the EPA's 2014 Rule establishing requirements pursuant to Clean Water Act (CWA) section 316(b) for cooling water intake structures (CWIS) at existing facilities.
