

# ARIPPA AMD/AML Reclamation Grant

**Deadline to apply is April 15, 2025**

## PURPOSE

The Appalachian Region Independent Power Producers Association (ARIPPA) is partnering with the Eastern and Western Pennsylvania Coalitions for Abandoned Mine Reclamation, EPCAMR and WPCAMR respectively, to offer competitive awards to watershed and conservancy organizations facilitating abandoned mine drainage (AMD) and/or abandoned mine land (AML) remediation projects in Pennsylvania. Awards are granted under the guidance and administration of EPCAMR and WPCAMR. The amount distributed by ARIPPA in 2025 will be \$6,000. However, the total grant award could potentially increase depending on contributions from other donors.

## BACKGROUND

Organized in 1989, ARIPPA is a non-profit trade association comprised of independent electric power producers, environmental remediators, and service providers located in Pennsylvania, Virginia, and West Virginia that use coal refuse as a fuel to generate electricity. Utilizing circulating fluidized bed (CFB) boiler technology to convert both anthracite and bituminous coal refuse into electricity, ARIPPA plants also provide unique multimedia environmental benefits by combining the production of energy with the removal of coal refuse piles and reclamation of the land for productive purposes. Today, there are 10 such CFB facilities in Pennsylvania and one each in Virginia and West Virginia.

ARIPPA plants are important contributors in the cleanup of AML sites and the associated air and water pollutants throughout the Appalachian region. To date, the Pennsylvania facilities alone have remediated more than 250 million tons of coal refuse, improved or restored more than 1,200 miles of streams, and reclaimed more than 7,200 acres of abandoned mine lands in the state.

However, much work remains to address this problem. AML projects in particular are costly and long-term endeavors often taken on by non-profit organizations that operate through grant funds. According to the Pennsylvania Department of Environmental Protection's (DEP) Mining and Reclamation Advisory Board (MRAB), the average cost of an AML project is at least \$8,000 per acre. If AMD is present on those lands, the cost could be even higher. The ARIPPA AMD/AML Reclamation Grants are designed to help environmental organizations and conservation districts continue their efforts toward improving our environment.

## PARTNERS

*EPCAMR and WPCAMR are non-profit organizations working to encourage the reclamation, remediation, and redevelopment of lands and streams polluted by historic coal mining. They serve as liaisons between industry, government agencies, and watershed organizations and offer conferences, educational opportunities, and technical assistance. They endorse state-of-the-art technologies in conjunction with grassroots efforts to solve AML problems. Both EPCAMR and WPCAMR support the efforts of ARIPPA and administer the ARIPPA AMD/AML Reclamation Grant program.*

Grants up to a maximum of \$3,000\* are awarded to at least one eligible environmental organization or conservation district in the anthracite region and one in the bituminous region in the Commonwealth of Pennsylvania actively working on AMD/AML issues. The amount granted is dependent upon demonstrated need.

\*The maximum award could potentially increase based upon contributions from other donors.

## ELIGIBILITY REQUIREMENTS

### Eligible Applicants:

- Environmental organizations with 501(c)(3) non-profit status or conservation districts in Pennsylvania are eligible to apply. Organizations without 501(c)(3) non-profit status must identify a qualified non-profit to administer the grant's finances if awarded.
- Applicants must provide a letter stating the organization supports ARIPPA, including the removal and conversion of coal refuse into alternative energy and the beneficial use of CFB ash for AML/AMD reclamation purposes.

### Eligible Use of Funds:

Grants will be given for projects related to AMD/AML reclamation. Eligible projects include but are not limited to the following:

- Operations, maintenance, and rehabilitation of AMD treatment systems
- Stream monitoring equipment purchases
- Analyses and watershed plans
- Vegetation management and erosion control
- Educational purposes to promote AMD/AML reclamation
- Supplies for trash cleanups
- Drone purchase and training to use as a tool to promote AMD/AML reclamation

Recipients are expected to use grant funds as outlined in their proposal and projects should be completed between August 2024 and August 2026.

### Grant Recipient Responsibilities:

IMPORTANT - Upon receipt of funding notification, your organization is required to do all of the following:

- Recognize ARIPPA's, EPCAMR's, and WPCAMR's sponsorship in your organization's newsletter or similar publication.
- Recognize ARIPPA, EPCAMR, and WPCAMR in all media and publicity materials distributed by your organization as you promote your project. You are also encouraged to solicit local print media to write a story about the project.
- Prominently display ARIPPA's, EPCAMR's, and WPCAMR's name on any project-related reports, handouts, signage, and websites.
- Notify ARIPPA, EPCAMR, and WPCAMR when the funded project is completed and follow up with photos and narrative of the work that was completed.

# APPLYING FOR THE ARIPPA AMD/AML RECLAMATION GRANT

To apply for a grant, please do the following:

- 3) Submit one (1) complete copy of your grant application with all attachments and supporting documentation to [anne@wpcamr.org](mailto:anne@wpcamr.org) by the above deadline. Be sure to attach all the required documents listed in the *Application Checklist* section on the last page to your email. Please send attachments in either Word document or PDF formats.

**Your coal region's representative can answer general application submittal questions and can provide your organization with literature on the beneficial use of coal ash.**

**DATE** – The date in which your application is submitted.

**PROJECT TITLE** – Title of the project your organization is applying for grant funding.

**PROJECT LOCATION** – Please provide a map of where the project will take place.

**WATERSHED** – List the watershed in which the project will take place.

**COUNTY** – List the county in which the project will take place.

**MUNICIPALITY(IES)** – List the municipality(ies) in which the project will take place.

**EXPECTED PROJECT START & END DATES** – Estimated project start and end dates.

**ORGANIZATION** – Name of the organization applying for the grant.

- b) How will this grant help your organization attain its goals and objectives?
- c) What current partners do you have for this project? What additional partners do you hope to bring on board?
- d) What long-term plan will this grant assist your organization?
- e) Please provide two (2) digital photos of the project. We prefer one preconstruction and one post construction photo.

**BUDGET NARRATIVE** – Please include specific items for which grant money is requested.

**PROJECT TIMELINE** – Include start date, expenditure date(s), and expected tangible outcome date(s).

**STAFF & ORGANIZATIONAL INFORMATION** – List of your organization's staff, officers, and/or board members, including their contact information.

## ADDITIONAL DOCUMENTATION

**IRS 501(C)(3) DETERMINATION** – Copy of your organization's IRS 501(c)(3) tax-exempt determination letter. In the case of those organizations without non-profit status, include a copy of your pass-through organization's tax-exempt determination letter.

**ARIPPA SUPPORT LETTER** – Documentation of your organization's support of ARIPPA, including the removal and conversion of coal refuse into alternative energy and the beneficial use of CFB ash for AML/AMD reclamation purposes on your organization's letterhead.
